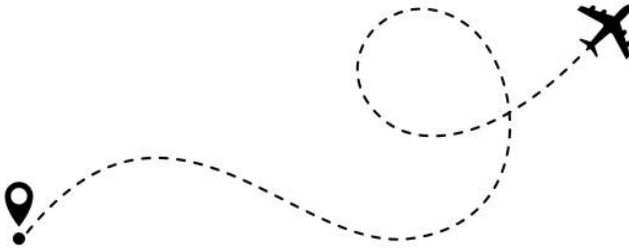

INTRODUCTION

*“What is the matter with them that they
disregard (with aversion) tathkirah (advice and
admonition) as if they are
WILD DONKEYS FLEEING FROM A LION”
(Al-Mud-dath-thir, 49, 50, 51)*

MINAB –the so-called *Mosques & Imams National Advisory Board of UK*, is most appropriately depicted in the Qur’aan Majeed as *Humurum Mustanfira* or “Wild Donkeys which flee from a Lion”. The Lion in Qur’aanic context of the relevant Aayat refers to the Shariah of Allah Ta’ala. Those who take flight from the Shariah and seek guidance and direction elsewhere are termed by Allah Ta’ala ‘*Humurum Mustanfira*’ (*Wild Donkeys*).

This group of charlatans masquerading as Ulama have become agents peddling the haraam vaccine – Devil’s Potion – for the Pharma Satanists. These miserable characters have descended into a cesspool of inequity with their fraudulent interpretations of the Qur’aan and Ahaadith to accord Shar’i sanction to the Potion of Iblees.

These juhhaal Wild Donkeys fleeing from the Shariah shamelessly peddle the haraam wares of the Pharma

Cartel despite the grave harms and filth of the devilish potions – harms and filth confirmed by innumerable experts in a deluge of writings. Acting as agents for the government and the Pharma Satanists, they have betrayed Islam and the Ummah. Indeed they are among the Signs of Qiyaamah. Rasulullah (Sallallahu alayhi wasallam) said that towards the approach of Qiyaamah *“the worst of the people will be the ulama”*. The assembly of the ulama-e-soo’ (evil ulama) is the worst calamity which has befallen the Ummah. The primary factor for the ruin of the Ummah is *Hizbush Shaitaan (the Legion of the Devil)* among whom are the Wild Donkeys of the UK Minab.

The ensuing pages are a brief rebuttal of the copro-drivel which the Wild Donkeys have excreted and deceptively adorned with Qur’aanic Aayaat and Hadith narrations to bamboozle unwary and ignorant Muslims. These miserable Wild Donkeys have, without any compunction, deemed it appropriate to bring the Pharma Satanists within the ambit of Qur’aanic approval thereby bestowing an elevated pedestal to the kuffaar Satanists who have been responsible for maiming, injuring and killing millions of people, mostly children, with their haraam poisonous devilish potions.

With bootlicking and hindlicking these Wild Donkeys of the UK Minab are crawling behind the Yahood and Nasaara into the *‘lizard’s hole’* in their drunken stupor of emulation. This sordid satanic degree of imitating and following the Yahood and Nasaara has been termed by Rasulullah (Sallallahu alayhi wasallam), *‘following into the lizard’s hole’*.

It is their belief that the vaccine potion of Iblees can thwart Malakul Maut, and that Maut can be averted by means of the satanic method of vaccination, i.e. the injection of filth and poison into the human body. Their total intellectual enslavement to the kuffaar has transformed these vile molvis and sheikhs into Wild Donkeys who flee from the Lion, i.e. from the Shariah of Allah Ta’ala.

Muslims should beware of these charlatans who masquerade as Islamic authorities. They are experts in shaitaniyat. For the safety of Imaan and for the protection of physical health, the shaitani advices of the Wild Donkeys must be incumbently rebuffed.

‘THE FLIGHT OF WILD DONKEYS’

*“What is the matter with them for ignoring the tathkirah (i.e. the Qur’aan and Sunnah)? Like wild donkeys do they flee from the Lion”
(Al-Muddath-thir, Aayaat 49, 50, 51)*

This Qur’aanic epithet adequately describes the likes of the UK body called *MINAB (The Mosques & Imams National Advisory Board)*.

The ‘imams’ of this miscreant body have acquitted themselves like *wild donkeys* fleeing from a Lion. The Lion is the Shariah of Allah Ta’ala. These juhala UK imams of the silly cartel are like *Humurum Mustanfira*.

The position of this cartel of wild donkeys as outlined in their article on the satanic covid vaccines, is the position which the atheists have excreted into their brains. It is a haraam position which has absolutely no support in the Shariah.

In its misguided article, the Minab wild donkeys bray:

“It is certainly difficult for anyone not to feel a sense of fear, anxiety, and helplessness during the pandemic. We are being tested in our priorities and our ability to cope in a time of confusion and despair.”

If these Wild Donkeys had a valid understanding of the Qur’aan and Sunnah, they would not have disgorged bunkum to advertise their *jahaalat* (ignorance). The true Mu’mín believes and knows that every atom in creation operates by the direct intervention of Allah Ta’ala. Even the movement of an ant and the rizq of a worm in the darkness of the earth underground is provided by Allah Ta’ala Who has direct control.

The ‘*sense of fear, anxiety and helplessness*’, is the attribute of those who have either no Imaan or of those whose Imaan dangles on a thread. They are on a disastrous precipice of the Fire. Of concern to the Mu’mineen are only the assault on the Deen which the vile molvis, moron sheikhs and wild donkeys such as the Minab gang are aiding and abetting. All of these Wild Donkeys and Hizbush Shaitaan (the Cartel of Iblees) are in league with the atheists kuffaar in the plot to undermine Allah’s Shariah, hence they flee from the Shariah (the Lion) and seek succour in the kufr hypothesis and satanic theories of the atheists.

Muslims who have their focus on Allah Ta’ala are not ‘helpless’. Wild Donkeys are helpless and dwell in confusion. Confusion and despair are not among the attributes of the Mu’mineen. The Qur’aan Majeed’s theme is: *“Only the kaafireen despair of Allah’s Mercy.”*

Tawakkul

Beginning their zigzag trajectory to convince Muslims that the haraam vaccines are halaal, the *Humurum Mustanfira* aver:

“Tawakul (reliance on Allah) does not preclude taking measures to relieve oneself and others from tribulation.”

The purport of this statement is to minimize the significance and importance of Tawakkul. The Tawakkul dimension has been introduced as a red herring to deflect the focus from the Shariah – from the haraam protocols and haraam vaccines. Regarding Tawakkul, Rasulullah (Sallallahu alayhi wasallam) said:

“If you adopt Tawakkul in the proper meaning of Tawakkul, Allah will feed you like He feeds the birds. They emerge (from their nests) hungry in the morning, and return satiated by the evening.”

The Minab characters are addressing an audience consisting of crass materialists – people who have sold themselves to the dunya. The brains of these people are not conducive for cognitive engagement. They have no need for pontification in the realm of Taqwa and Tawakkul. None of them submit to the demands of Tawakkul. Tawakkul is the furthest from their minds. What then is the purpose of harping negatively on Tawakkul? Tawakkul is a superfluous introduction into the satanic covid protocols/vaccine debate. The Wild Donkeys and Hizbush Shaitaan have cunningly introduced Tawakkul as a red herring. It is a dishonest diversionary tactic for the obfuscation of the ignorant and unwary.

The Ulama-e-Haqq who are opposing and damning the devil’s protocols and the potion of the devil, i.e. vaccines, are not stating the case of the Shariah on the basis of Taqwa/Tawakkul. The basis for the prohibition is the *Zaahiri* Law of the Shariah, which does not touch on the Taqwa factor. Every moron understands that despite the cultivation of Taqwa being an imperative demand of the Qur’aan and Sunnah, the Fatwa for mass consumption and implementation by the rank and file is NOT the product of Taqwa.

What the Ulama – the true and genuine Ulama – claim regarding the villainy of the views of the bootlicking

Wild Donkeys and Hizbush Shaitaan, pertains to simple, straightforward issues of halaal and haraam. It is not an issue of high Taqwa which precludes latitude and concession within the confines of the Shariah. Taqwa is something else. It is a concept of which the Wild Donkeys of the UK and the moron molvis of Hizbush Shaitaan lack the haziest understanding.

The twaddle which they disgorge is the effect of brains having been rendered dysfunctional by either the ‘*touch of shaitaan*’ or by divinely cast *rijs (filth)* on their brains as a result of their treacherous simulacrum which is the logical acquisition of bootlicking the atheists for the achievement of worldly and *nafsaani* objectives. Regarding the touch of Iblees, the Qur’aan Majeed states:

“They do not stand except as one who has been driven to insanity by the touch of shaitaan.”

Thus, they suffer from the malady of *Takhabbatush Shaitaan* (satanic manipulation of the brains). Regarding divinely cast *rijs*, Allah Ta’ala says in the Qur’aan Majeed:

“Thus, does Allah cast RIJS (filth) on those who lack intelligence.”

All bootlickers of the atheists and kuffaar in general are bereft of intelligence, i.e. *Aql* adorned with Taqwa

which is vital for the sustainment of Imaan. However, the Fatwa of *hurmat*, i.e. the prohibition of the devil’s potion and protocols, is not reared on the premises of Taqwa and Tawakkul.

In simple terms, the genuine Ulama say that the potion of Iblees (vaccines) and the protocols of Iblees are HARAAM on the basis of *Nusoos* of the Shariah. This *hurmat* is not contended on the basis of Tawakkul or Taqwa. The cultivation of Taqwa is Waajib for all Mu’mineen. It is not the preserve of the select Auliya. In fact the Auliya of lofty status had once been members of the laity. It was by the cultivation of Taqwa that they attained their lofty pedestal of *Roohaaniyat* and *Qurb* (Nearness) to Allah Ta’ala.

The minimum degree of Taqwa which is Waajib on every Mu’mín is to dwell within the confines of the *Zaahiri* Shariah. Rasulullah (Sallallahu alayhi wasallam) said: “*Halaal is clear (conspicuously clear). Haraam is clear. In between is the category of Mushtabah.*” Abstention from *Mushtabah* (Doubtful) is WAAJIB. It is not optional as the Wild Donkeys and others of their satanic ilk propagate. Adherence to the Fiqhi demands of the *Zaahiri* Shariah is incumbent, and this is not Taqwa or Tawakkul, etc.

Abstention from consuming carrion, pork and liquor is not within the scope of the Taqwa which is the speciality of the select Auliya and Sufiya. Such abstention is compulsory for all Muslims. This is the minimum degree of imperative Taqwa below which there is no other degree. So, when it is said that the potion of Iblees (the vaccine) and the protocols of Iblees (mask, devil’s distance, etc.) are haraam, the fatwa comes within the purview of that minimum degree of Taqwa which incumbently necessitates abstention from carrion, pork, liquor, fornication, etc. Thus, the fatwa of prohibition regarding carrion does not belong to the realm of higher Taqwa of which Tawakkul is a major attribute. The fatwa proclaiming liquor and pork haraam is not within the purview of Taqwa and Tawakkul. But this is precisely the falsehood which the *Humurum Mustanfirah* and *Hizbush Shaitaan* are satanically camouflaging with Deeni terminology and justifying with Qur’aanic verses and Hadith narrations which do not have the remotest relationship with the issues under debate.

This is why they are branded as ‘zigzaggers’. They commence their deception with a deeni hue to mislead the masses. But the conclusion of their corrupt ‘fatwas’ is invariably in diametric conflict with the *Zaahiri* Shariah. The measures which the Wild Donkeys and Hizbush Shaitaan promote at the behest of their atheist

masters are not condemned by the Ulama on the basis of Tawakkul. There are glaringly conspicuous Qur’aanic and Hadith *Nusoos* to substantiate the prohibition. We have explained the basis of the prohibition in numerous articles and booklets which are available on our website.

With cunning hyperbole in their stupid writings and talks, they create the red herring of Tawakkul to bamboozle people. Thus, these Wild Donkeys say:

“Believing in Allah’s decree (qadr) whilst resorting to the means which Allah has set out in order to achieve outcomes is part of the sunnah of the Prophet Muhammad (peace be upon him). The Prophet (peace and blessings be upon him) has famously advised: Tie the camel and trust in Allah.”

This is their kind of typical shenanigan motivated by nothing other than bootlicking the kuffaar, the atheists and the government who has become their deity and idol of worship. Their aforementioned averment is not contested or rejected. However, they have cunningly misapplied their brains and dishonestly presented this averment to deceive and misguide.

Allah Azza Wa Jal has undoubtedly created for us means and ways of attaining our lawful worldly objects. There is absolutely no contention on this issue.

No one has claimed anything in abnegation of this reality. The Ulama who proclaim the *hurmat* of the potion and protocols of Iblees, utilize all the lawful means, ways and agencies permitted by the Shariah for the acquisition of needs. So why should they exclude from the ambit of permissibility the means which these Agents of Iblees are propagating? The simple response is that the methods and means advocated by the Wild Donkeys at the behest of the atheists are HARAAM. The ways and means allowed by the Shariah are halaal creations of Allah Ta’ala. When the Ulama say that carrion is haraam, it will be only an agent of Iblees who will falsify this truth by claiming that mutton is halaal and that those who say that carrion is haraam are relying on Tawakkul.

Rasulullah (Sallallahu alayhi wasallam) said: “*Allah has not created the cure of my Ummah in things which are haraam.*” Haraam measures are for the kuffaar and shayaateen, not for Muslims. Allah’s Decree precludes utilization and adoption of haraam medicine and ways which are not created for this Ummah. To “*achieve outcomes*” by resorting to the “*means set out*” by Allah, never means the adoption of haraam, of filth, of ways which are in conflict with the Shariah, and all of this at the behest of the atheists who dangle the chimera of haraam dollars in front of these molvis and sheikhs – the Wild Donkeys – to achieve their

conspiratorial goals with the aid of the bootlicking Wild Donkeys. Only halaal ways are permitted. But the whole gamut of covid measures offered to the Wild Donkeys by the atheists is HARAAM in terms of the *Zaahiri* Shariah, not on the basis of Tawakkul as the moron donkeys claim.

No one has denied the validity of tying the camel. But this never means employment of haraam measures. The camel has to be tied correctly, not throttled to death. The camel is a halaal measure while the devil's protocols and potions are absolutely haraam. The analogy is thus false, cunning and misleading.

Continuing the narrative of falsehood by spinning another lie, the Wild Donkeys of the UK minab, say:

“One of the lessons we learn from this Prophetic statement is that we need to use all resources available to us and make reasonable efforts to achieve what is in our interests, while at the same time relying entirely on Allah for the outcome.” (Our emphasis).

This is false. It is not permissible for Muslims to use all available resources. Urine, excrement, liquor, pork and many haraam items are also available resources in which there are cures and other benefits, but Islam proscribes filth, poison and the like. The utilization of *all* available resources is not permissible for Muslims.

Yes, it is befitting for atheists, mushrikeen and kuffaar in general to make use of *all* available resources. Muslims in this dunya are living in a veritable spiritual minefield. We are constrained by the Command of Allah Ta’ala to pick our way through this labyrinth of meandering pathways in this minefield. Without care, we shall blow up our Imaan.

Another palpable lie is their hollow advice of “*relying entirely on Allah*”. This is a dastardly canard. If they had even understood the meaning and purport of this statement, never would they have ventured to halaalize the filth, harms and poisons of the protocols and vaccines of the atheists. Reliance on Allah Ta’ala is the very antithesis of utilizing haraam measures on which settles the Curse of Allah Ta’ala. Reliance on Allah Ta’ala gravitates the servant to halaal and tayyib, not to haraam and najaasat.

Covid vaccines

Echoing the tune of their masters, the bootlicking morons of the UK minab cartel of wild donkeys, say:

“Since the beginning of this pandemic, efforts have been made across the globe to develop a treatment to save lives. Thankfully, within a short period of time human endeavours have born results and vaccines against covid-19 have emerged.”

These morons whose brains are destitute and intellectually bankrupt exhibit their ignorance of the meaning of a pandemic and the meaning of treatment. The handful of people whose deaths are attributed to the covid virus could never have been saved by any means or treatment which the accumulation of human and jinn brains could fabricate. The Qur’aan Majeed informs us:

“No person will die except with the permission of Allah at the appointed time.”

Relative to the population of the world the fraudulently recorded ‘covid’ deaths are an insignificant number. More people die annually with the usual seasonal influenza and other causes. Experts have compiled statistics to prove the fraud and falsehood of the covid plot engineered by the Bill Gates cartel which has harnessed the UK Wild Donkeys and Hizbush Shaitaan for promoting their satanic covid wares. Innumerable kuffaar experts and scientists have proven the harms and filth of the vaccines. But the gang of plotters simply ignores the deluge of evidence which has exposed the plot. But the jaahil molvis and sheikhs in pursuit of nafsani objectives continue dancing like baboons to the tune and dictation of the atheists who are hell-bent on the boodle of billions of dollars in the wake of the Devil’s Potions.

The belief that those who have died during this bogus ‘pandemic’ would not have died if there had been the latest Devil’s Potion, is categoric KUFR. Everyone dies at his/her prescribed moment of *Maut*. The belief of the ability to save lives is extremely and satanically *contagious*. This rabidly contagious spiritual disease has infected innumerable molvis and vast masses of the Ummah who all believe in the ‘power’ of the atheists to save lives with their filthy, poisonous satanic concoctions. That the UK Wild Donkeys of minab subscribe to this belief of shirk is conspicuous from their socialistically prepared article designed to advertise the shaitaani vaccine wares of the atheists whom they are bootlicking. Their advice to Muslims regarding the Devil’s Potion and protocols is a disingenuous attempt to accord Islamic credulity and acceptability for the ‘pandemic’ narrative of their atheist masters.

It is imperative for Muslims to understand that *entire reliance* on Allah Ta’ala deceptively and hypocritically mentioned by the Wild Donkeys is not a mental hobby which could be fitted into the ideas and theories of the atheists. Islam is immitigable. Its Shariah is not available for expurgation of any of its tenets which the modernist Muslim’s brain diseased with atheism deems to be antique. Thus, the *Laa adwaa* (Disease is not

contagious) concept substantiated by *Wahi* may not be interpreted immiscibly to strike a balance with the kufr theories of the atheist scientists and doctors whose brains are all fitted with the straitjackets of kufr by the intellectual brothels known as universities.

Disgorging and displaying their gross stupidity which reveals their intellectual enslavement to the atheists, the minab Wild Donkeys say:

“The Pfizer/BioNTech, Oxford-AstraZeneca and Moderna vaccines have been approved by the Medicines and Healthcare Products Regulatory Authority (MHRA), which is regarded as the most credible and trustworthy authority of its kind in the world.”

The monstrous stupidity of these Wild Donkeys is indeed laughable. Who did the “approval” of the potion of shaitaan manufactured by the Bill Gates conspirators? And, who has regarded the mercenary kufr body MHRA to be the “most credible and trustworthy authority in the world”? The testification of atheists of other atheists has no validity in the Shariah. Approval and accreditation of atheists by atheists are an apodal of the *obscurum per obscurius* kind which the minab Wild Donkeys have elevated to the status of *Wahi*. With such silly and stupid ‘approval’ these miserable UK molvis and stupid imams seek to

override the Shariah and make palatable for Muslims the devil’s potions and concoctions, and that is the effect of total eschatological bankruptcy. Their ‘belief’ in Allah Ta’ala and His Shariah is restricted to verbal profession devoid of the heart’s conviction.

Mu’mineen search for the approval or disapproval of the Shariah. What is not trustworthy and credible in terms of the Shariah is the product of Iblees. Instead of providing Shar’i approval, the moron Wild Donkeys in pursuit of their worldly objectives equate the approval of atheists to the approval of the Shariah. What is wholly untrustworthy in terms of the Shariah has become trustworthy for this miserable cartel of molvis and imams who are unable to distinguish between right and left, night and day.

The *‘level of scrutiny vaccines are facing is unprecedented’* and entirely acceptable to the juhala of minab who are all the dollar slaves of the atheists plotters. The knowledge of the morons regarding the devil’s potions is absolutely nil. Based on their nil awareness of the vaccine *Rijs*, they most audaciously issued their confounded satanic ‘halaal certificate’ to entrap the ignorant masses. Their approval is devoid of any Shar’i substance. They should spell out their corrupt, shaitaani basis for their baatil claim of

‘approval’. Valid approval is only approval in terms of the Shariah, and so too is trustworthiness.

Compounding their confusion and *jahaalat*, the Wild Donkeys aver:

“The British Islamic Medical Association (BIMA) have also shown confidence in the vaccines and are recommending taking vaccines.”

The recommendation and confidence displayed by the morons of the so-called ‘islamic’ doctors cartel is in fact darkness piled on darkness as Allah Ta’ala says in the Qur’aan Majeed:

“(The likeness of their misdeeds) is like darkness (zulmat on zulmat) in a deep ocean. He (the moron) is covered (in this darkness) by wave upon wave above which there is a (dark) cloud: darkness piled on darkness. When he (the wild donkey) takes out his hand, he is unable to see it. He for whom Allah has not ordained Noor, there will be no Noor.”

These *zanaaqdah* doctors dwell in intense darkness piled on darkness. But these jaahil molvis of the minab cartel of wild donkeys turn to these *zanaaqdah* for guidance instead of turning to Allah’s Shariah (the Qur’aan and Sunnah) for directive and guidance. The vast majority of so-called Muslim doctors hooked on to

so-called ‘islamic’ medical groupings are in fact murtaddeen masquerading as Muslims.

The *mudhilleen* of minab, in furtherance of the Bill Gates conspiracy, deliberately turn a blind eye towards the mass of conflicting evidence – expert, scientific evidence damning the claims of the sorcerers of the ‘approved’ vaccines. These scientist who condemn the vaccines as well as the gamut of Ibleesi protocols are of the same hue of atheism as are the slaves of Bill Gates. They are not some orthodox Ulama inhabiting remote villages, who have no understanding of the satanic medicines and remedies saturated with filth and poisons. Why do these Wild Donkeys confine their stupid superficial scrutiny to only the narratives which strike responsive chords in the plots of Bill Gates?

Any Mufti who has some *Khauf* for Allah Ta’ala will look at all the available information of all hues of expertise before issuing a fatwa on a matter of which his knowledge is nil. But the moron Wild Donkeys pretend that the only opinion existing on the Devil’s Potions is the view of the slaves of Bills Gates. They conduct themselves in the same style as the mainstream press which propounds and promotes only the satanism excreted by Bill Gates and his company of Devils.

The bestowal of confidence in vaccines by the zanadaqah doctors is no better than approval by Iblees himself. Ulama are required to present Shar’i evidence. In this regard, the minab *Humurum Mustanfirah* and *Hizbush Shaitaan* have miserably failed.

Myths?

In a disingenuous attempt to vindicate their satanic stance, the Wild Donkeys of minab allege:

“The emergence of the vaccines has also raised some legitimate questions but at the same time some myths are also being circulated by poorly informed individuals.”

What are these ‘myths’, and who is/are circulating them? The legitimate questions all arise from the contrary view and claim of top atheist scientists and expert kuffaar doctors who vehemently deny and deride the vaccines and those behind the sinister satanic plot. They are not *“poorly informed individuals”* as the Wild Donkeys allege. It is stupidly and satanically arbitrary to reject the contrary opinion, and to dogmatically assert the view which conforms to Bill Gates and his Pharma cartel. While the vaccine theory propounded by the Pharma devils is a myth, the Wild Donkeys proclaim the opposite view of expert scientists as ‘myths’. The opposite view is not the

opinion of Ulama who lack in the knowledge of modern science. The view which condemns and damns the view of Bill Gates and the Pharma satanists, is the opinion of atheist scientists and kuffaar doctors who are not the slaves of Bill Gates as are these Wild Donkeys and the doctors of the so-called ‘islamic’ medical associations.

Preservation of life?

Arguing in favour of the Devil’s Potions and protocols, the minab Wild Donkeys say: *“Whilst Allah is the ultimate Healer, we are encouraged to do our best to preserve the gift of life given to us by Allah. The Qur’an commands: “....do not cast yourselves into the jaws of ruin by your own hands and do your best. Allah loves those who do good.”*

This glorious Qur’aanic Aayat has absolutely no reference and no relationship with the devil’s vaccines. Preservation of life stated in this Aayat firstly does not preclude Taqwa which constrains abstention from adoption of even lawful methods, e.g. abstention from medical treatment, abstention from earning for those devoted to Ibaadat, etc. Abstention from medicine is permissible in the unanimous opinion of all authorities of the Shariah. Thus, he who abstains from medicines and dies ostensibly as a result of his abstention does

not come within the purview of the castigation stated in this Qur’aanic Aayat.

Once, Hadhrat Umar (Radhiyallahu anhu) was confined to bed with severe illness. When it was suggested to call a physician, Hadhrat Umar (Radhiyallahu anhu) commented: *“If I know that my cure is in only raising my hand and touching my forehead, I shall not do so.”*

This was the attitude of numerous Auliya, and even of pious persons who were not of the level of *Wilaayat* of the selected Auliya. Casting oneself *“into the jaws of ruin”* refers to the perpetration of haraam acts. Thus, in this regard, submitting to the satanic system of vaccination will come within the scope of the prohibition stated in this Aayat. In other words, according to this Aayat, it is haraam to adopt vaccination. It is haraam to have the excrement of satanic filth and poison injected into the human body which is an Amaanat to preserve and sustain. It is haraam for both healthy and sick persons to cast themselves into ruin by adopting the haraam satanic system of vaccination.

The stupidity of the Wild Donkeys becomes more apparent with their gross misinterpretation of the Aayat. The actual purport of the Aayat and its *Shaan-e-*

Nuzool were abstention from Jihad against the Kuffaar. Hadhrat Ayyub Ansaari (Radhiyallahu anhu) explained that this Aayat was revealed to castigate the Ansaar of Madinah who had commenced attending to their farms and businesses at the cost of non-participation in Jihaad. As a result of this Qur’aanic stricture, Hadhrat Ayyub Ansaari (Radhiyallahu anhu) devoted the balance of his life in Jihaad. He was finally martyred in the attack on Constantinople and there he lies buried at the walls of this city.

One of the basis for the *hurmat* of vaccines is this very same Aayat cited by the Wild Donkeys of the UK minab. The proven dangers and harms, and the content of *Rijs*, render vaccines haraam, hence submitting to this satanism is to cast oneself into the jaws of ruin which is haraam.

Further misinterpreting this Qur’aanic Aayat, the U.K. Wild Donkeys say:

“Classic Maqasid al-Shariah (the higher objectives of Islamic law) consider the protection and preservation of life as the cardinal value of Islamic morality. In addition to saving one’s own life, Islam emphasises the need to save others’ lives too.”

This is the type of ‘classic’ misinterpretation of zanaadaqah designed to misguide the ignorant and unwary with deception motivated by worldly and nafsaani goals and desires. The devil’s concoctions (vaccines and the covid protocols), are on the contrary haraam and can never be regarded as endeavours to preserve life. Because Bill Gates and other Pharma Satanists wallowing in kufr and janaabat maintain that their evil potions and tricks are life preserving, only morons of the worst type will bring such satanism within the scope of the Higher Objectives of Islam.

Among the foremost and most important aspects of Maqaasid of the Shariah is abstention from Haraam which has priority and greater significance than engrossment in Nafl Ibaadat. Furthermore, while the utilization of halaal medicine is *mubaah*, abstention therefrom even if it leads to death is NEVER in conflict with any precept of the Shariah. The lopsided corrupt understanding of Maqaasid-e-Shariah of the moron Wild Donkeys and others of the same hue and ilk is utterly baseless having no standing in the Shariah.

While abstention from halaal medicine is permissible, and for some laudable on the basis of Taqwa, abstention from vaccines is Waajib since these satanic potions are haraam harmful substances of the devil. Only brains convoluted by satanism understand

abstention from haraam, from poison and filth to be in conflict with the Maqaasid-e-Shariah.

Maiming, injuring and killing people with the Devil’s Potion are not ways which Islam tolerates for the so-called ‘preservation of life’. Preservation of life until its moment of expiry, is valid and permissible only in ways which are valid in terms of the Shariah. But a method which itself causes ruin and destruction NEVER comes within the purview of even *Ibaahat* (*Permissibility*), leave alone incumbency.

For people of weak Imaan, *Tadaawi bil haraam* (haraam medicine/treatment) is *mubaah* (permissible). It is not incumbent. But treatment with vaccines is haraam for the simple reason that it is the opposite of medicine. It is filth and poison which injure, maim and kill. It can never be brought within the purview of *Tadaawi bil haraam*. One of the conditions for the permissibility of adopting this rule, is that there must be *shifa’* (*cure*) in the haraam medicine. But in regard to vaccines, instead of *shifa’*, it ruins, injures, maims and kills. It causes diseases to flourish. It is thus satanically erroneous and fallacious to argue the haraam vaccine on the basis of *Tadaawi bil haraam*.

In fact, the morons of minab have even elevated this shaitaani excrement to the pedestal of *Wujoob*. Indeed,

their brains have been corrupted by the urination of Iblees. With breath-taking *jahaalat*, these Wild Donkeys say:

“Intentionally exposing oneself to a life-threatening disease, or refusing treatment is like facilitating one’s death.” Then the juhala liken this to ‘suicide’. The *rijs* with which Allah Ta’ala has cursed these Wild Donkeys is conspicuously portrayed by their submission to the Bill Gates cult of satanism.

On what basis have these moron devils concluded that abstention from medical treatment is suicide? What is the proof for this blatantly false ‘fatwa’ sucked from the thumb of shaitaan? Abstention from halaal medicine was the norm for the Auliya. Abstention from haraam medicine, despite permissibility, was the practice of even Muslims of little Taqwa. Even today, innumerable Muslims abstain from medicines which have alcohol as an ingredient.

While abstention from halaal medicine belongs to the domain of Taqwa and Tawakkul, abstention from vaccines is *Waaajib* because these substances are not medicine, not even haraam medicine. It is Satanist poison and filth. Only morons whose brains have been convoluted by the spell of Iblees are capable of claiming that such filth and poisons as vaccines come

within the scope of medicine, and that too ‘waajib’ medicine. There is no concept of Waajib medicine in Islam.

Further, what is the meaning of “*Intentionally exposing oneself to a life-threatening disease....*” ? In their warped understanding, this means to abstain from the satanic covid protocols and the devil’s potion. On the contrary, abstention from these devilish effects is compulsory. The ‘exposure’ which these morons have mentioned is based on their belief that disease is contagious, hence according to their corrupt understanding it is necessary to follow all the haraam protocols which the atheists have designed for their hallucinations.

On the other hand, those who do not subscribe to the kufr belief of contagion have no qualms mixing with the sick and ailing. Rasulullah (Sallallahu alayhi wasallam) ate with the leper from one bowl. He instructed the leper to “*have tawakkul and to eat*”. While this is exposure to a life-threatening disease according to the Wild Donkeys, it is most laudable to Muslims whose beliefs have not been corrupted by satanism.

Propounding more copro-rubbish, the Wild Donkeys of the UK minab say:

“Seeking medical treatment or getting vaccine can be considered as part of belief in the power of Allah.”

They have further exhibited their jahaalat with their stupid interpolation. Seeking medical treatment is permissible. Its predication to Aqeedah (Belief) is the same as believing that eating bread and drinking water are permissible. In other words, it is incumbent to believe that whatever is not haraam is permissible. But it is utterly false to aver that it is part of belief to incumbently submit to medical treatment. In addition, with regard to vaccine treatment, it is haraam filth and poison, hence abstention is Waajib. While urine has medical properties according to kuffaar experts, vaccines are satanic poisons and filth concocted by the Pharma Satanists for the billions of boodle-dollars which this satanism will rake in for them. There is simply no scope in Islam for vaccines as being medicine, not even medicine of the haraam variety.

There exist a plethora of articles and books published by kuffaar scientists and experts on the dangers, harms and filth of vaccines. Searchers of the truth must necessarily study such books in order to gain an informed idea of the satanism which the Wild UK Donkeys are propagating at the behest of the Pharma conspirators.

Disease and its cure

In another bamboozling attempt, the Wild Donkeys cite the following Hadith:

“Allah did not send down any disease but that He also sent its cure. So treat sickness, but do not use anything haraam.”

The morons whilst citing this Hadith, remain blind to the command to “not use anything haraam”. *Haraam* ingredients and filth constitute the fundamental basis of western medicine. While there are cures for all sicknesses in the millions of species in the plant kingdom, the atheist scientists gravitate primarily to *najaasat*. Thus, they perennially search for cures in filth such as blood, excrement, urine, pus, foetal matter, carrion, especially pork, human organs, etc., etc. They inject filth from diseased animals into the bodies of healthy humans. But Allah Ta’ala has not created filth to be cures for Muslims, hence Rasulullah (Sallallahu alayhi wasallam) said: *“Allah has not created cure for my Ummah in things made haraam for them.”* Haraam and najaasat are favourites of the devils. Since these atheists worship devils, they gravitate towards satanism, hence their obsession with *najaasat*.

The abovementioned Hadith cited by the Wild Donkeys is a conspicuous indictment against the vaccine filth-poison. This Hadith damns vaccines, but the Wild Donkeys who have cited it are too stupid to understand that they have shot themselves in the foot with this citation. Vaccines are concoctions of haraam, najaasat and poisons. There is neither secret nor conundrum in this fact which is corroborated by a deluge of evidence, but the moron U.K. molvis remain blind, and that is because their confounded hearts are blind. The Qur’aan Majeed condemning such *Humurum Mustanfiraah* says:

“The (physical) eyes are not blind. But the hearts within the breasts are blind.”

When even beneficial medicine which is haraam may not be used according to this Hadith, by what stretch of intelligence is it permissible to use the satanic harmful concoctions prepared by the Pharma Satanists to treat even diseased people? The notoriety of injecting healthy persons with this shaitaani excrement is mind boggling. It is gargantuan satanism which stuns the Imaani brain. The Donkeys have cited this Hadith only to further display their cognitive dissonance.

Displaying more compound *jahaalat*, the moron scholars for dollars say:

“In another Hadith, the Prophet (peace be upon him) has urged that one should “seek out cure”. Accordingly, protecting oneself and others from potentially a life-threatening situation, getting vaccinated can be considered as seeking out cure that has been ultimately sent by the Lord Almighty.”

They shamelessly utter a blatant LIE on Allah Azza Wa Jal. The mushrikeen were notorious for claiming that their shirk and its artefacts were divine inspirations. These Wild Donkeys are following in the satanic footsteps of the mushrikeen by heaping falsehood on Allah Ta’ala. Allah Ta’ala does not command adoption of filth and najaasat as cure. Rasulullah (Sallallahu alayhi wasallam) said: *“Verily Allah is Nazeef (pure and clean). He loves nazaafat.”* But these morons have attributed condonation of filth and haraam to Allah Ta’ala.

The search for cure, even every moron who is sincere can understand, must be restricted to halaal and tayyib substances, not to excrement, urine, blood, pus and necrotized tissues of diseased animals. Allah Ta’ala does not send haraam and najaasat for the cure of His creation. Vaccines are satanic potions of filth and poisons. On what basis can such satanic filth *“be considered as seeking out cure that has been ultimately*

sent by the Lord Almighty.” ??? They endeavour to assuage their conscience with just any straw they can lay hands on, hence they stupidly cite Ahaadith and Qur’aanic Aayaat which they utilize and mismanipulate to extrapolate ‘fatwas’ appealing to the shayaateen and the atheists whose boots they are licking.

Haraam substances of vaccines

The Wild Donkeys of the UK minab allege:

“It is factually incorrect to say that the vaccines contain foetal cells and therefore should not be used. We are informed that the vaccines were not produced using foetal cell-lines in the final production of the vaccine.Further no animal products have been used to produce the vaccines that are being used in Britain.”

What is the basis for these claims? They rely on the information disgorged to them by the Pharma Satanists who pay billions of dollars to governments and to a variety of non-governmental entities such as the Wild Donkeys and Hizbush Shaitaan outfits all over the world to promote their shaitaani potions. Lies are inherent in shayaateen and their agents. They thrive on lies, falsehood, filth and whatever is haraam.

These Wild Donkeys, due to their commitment to the Pharma dollar creed, refuse to intelligently study the research documents and writings of the experts and scientists who have substantiated with scientific evidence the filth and danger of vaccines. Or perhaps they are too stupid to understand what the experts say, hence they content themselves with the kufr effluvium which their atheist masters vomit into their brains. Or the despicable worldly objectives which they are pursuing constrain them to pretend that no credible evidence exists to knock the bottom out of the claims of the Pharma Satanists.

For ascertaining factual information regarding the vaccines, the need is to acquire this from independent researchers, not from the manufacturers of the devil’s potion. Neither is the word of the vaccine manufacturers reliable nor is the stupid opinion of the UK Wild Donkeys of minab credible. The assurance and information provided by the criminals are to be summarily rejected. The truth cannot be expected from the Pharma Satanists whose sole objective is the billions of dollars.

The cunning morons of minab say that foetal cells are not used in “*the final production of the vaccine*”. Thus the morons concede that foetal matter is used at some stage of the production of Shaitaan’s potion. It

devolves on these juhala to examine the claims of the other experts and to refute each claim scientifically with valid evidence. Each claim of the opposition should be scrutinized and refuted factually and scientifically with evidence. It is simply stupid and unacceptable to just say: *“It is factually incorrect to say that the vaccines contain haraam substances....”* The opponents of the Pharma Satanists advance very very cogent scientific evidence for their condemnation and damnation of the Devil’s Potion. Such solid evidence cannot be dismissed by mere arbitrary denial without providing counter scientific evidence from the atheists whose slaves these donkey-molvis have become.

The Qalbul Maahiyat red herring

Another red herring of the Wild Donkeys is their presentation of the *Qalbul Maahiyat* principle. The total metamorphosis of a substance creates a different consequence. By means of metamorphosis a formerly haraam substance changes into halaal. The morons have presented this principle to support the vaccines whose ingredients are undeniably haraam. Their argument is that the filth and foetal matter, etc. due to the process of metamorphosis have been transformed into halaal substances. Their conclusion is ludicrously

baseless and is simply clutching at another straw to support the Pharma Thugs and Devils.

The metamorphosis of the haraam filth and poisons in vaccines is like the change which wine, excrement, urine, blood and pus added to dough undergo during the baking process to produce bread or cake. No intelligent person whose mind is not filthied and necrotized with kufr will ever accept that such bread/cake is halaal and tayyib fit for Muslim consumption.

The Wild Donkeys have latched onto this principle to pull wool over the eyes of the ignorant masses. Furthermore, why are they concerned with the metamorphosis principle when they maintain that the ingredients of the Devil's Potion are halaal according to the information fed to them by the Pharma Satanist conspirators?

Should we momentarily entertain the metamorphosis idea of the *RIJS* of which vaccines constitute, then too, vaccines having been proven to be disastrously destructive and ruinous, remain haraam. This potion of shaitaan can never be regarded as medicine. It's a combination of filth and poison. Thus, even if all the ingredients are 'halaal', it will not be permissible to inject the devil's poison into the body.

Vaccination?

The Wild Donkeys of UK minab, making a preposterously false claim state:

“Vaccination is a well-established and protective procedure against infectious diseases....”

This averment, in addition to its palpable falsehood, is kufr. Rasulullah (Sallallahu alayhi wasallam) had refuted with great clarity the kufr belief of disease being infectious/contagious. This theory of the atheists is the self-same hypothesis of the mushrikeen of bygone times. Islam has no truck with beliefs of kufr and shirk. The Wild Donkeys are promoting the agenda of the atheists in diametric conflict with the Shariah.

Furthermore, the claim of this filth being a well-established protective procedure is a despicable canard – a lie fed to these morons by the Pharma Satanists. They are too stupid to engage in honest research to establish the reality and the truth. Millions have suffered severely in the wake of the variety of types of vaccination programmes which the Satanists had implemented.

In fact, regarding the current covid vaccine, reports are emerging from all parts of the world of the severe ailments and harms caused to those morons who had volunteered to be vaccinated with shaitaan’s excrement. Their awareness and knowledge of vaccines and vaccination are deplorably despicable and stupid. In their stupid article they project themselves as experts in the field of the Devil’s Potion. But whatever stupidities they have disgorged are vomit lapped up from the excrement of the Pharma Satanists.

The principle of adopting the lesser harm

In another baseless and futile exercise to promote the satanic excrement of the Pharma Satanists, the UK Wild Donkeys of minab say in their disgorgement of copro-effluvium:

“However, it is possible that during the immune response, a person may get ill, but this will be a weaker form of illness than the person might otherwise have got. It is an established principle in Islamic law that a person can choose a lesser harm to ward off a greater harm (haml akhaff al-darratayn). This concern is therefore not of sufficient strength to render taking the vaccine impermissible.”

Their application of this principle further illustrates and confirms the *jahaalat* of these Wild Donkeys. They have not even understood the correct operation of the

principle of adopting the lesser of two evils/harms. When a Muslim is confronted with two evils and there is no third halaal option, and circumstances constrain adoption of one option, only then in such a scenario will it be permissible to adopt the lesser evil in order to escape the greater evil.

As far as even halaal medicine is concerned, such medicine whose cure is proven and established, and whether a person is healthy or sick, he is never confronted by two evils whose circumstances constrain him to adopt one option. The Shariah does not oblige Muslims to submit to medical treatment against their wishes, and against their Taqwa and Tawakkul. Thus, there is never a confrontation by two evils in a scenario where a halaal third option is available. And, in the vaccine scenario, regardless of the absence of a halaal remedy –i.e. even should it be assumed that there is no halaal remedy – the Shariah does not require us to make a selection between urine and faeces – between two existing evils which compel adoption of one.

Furthermore, the moron Wild Donkeys have failed to proffer the two evils from which to choose. The validity of the principle’s operation relies on current *existing* evils from which there is no escape via a third halaal route. The choice presented by the morons is between a sickness and a *mauhoomi* (imaginary) future

disease. Thus the Donkeys say that the ailments which the vaccine can create as ‘side effects’ are “*a weaker form of illness than the person might otherwise have got.*”

Consider a perfectly healthy person being vaccinated with filth and poison to induce disease in whatever hallucinated ‘mild form’ the sorcerers have in mind. This is the very first major HARAAM step. This person is not suffering from disease, and the issue of contracting a future disease is pure conjecture and satanic hallucination. There is absolutely no confrontation between him and two evils confining him in a cocoon from which extrication is possible only if one of the evils is adopted. But he is not confronted by any of the two imaginary evils.

The Devil’s act of vaccination induces disease in him. This so-called ‘little’ harm is not pitted against a future ‘huge’ harm – the future harm is pure shaitaani induced hallucination, induced to accord with a Pharma fed design. In this stupid devilish scenario the U.K.Wild Donkeys licking the boots and hinds of the atheists seek to employ the Shar’i principle of the ‘lesser evils’. Indeed their brains have been vermiculated by *Takhabbutush Shaitaan (the evil touch and spell of Iblees)*.

Now consider a sick man. It is haraam to inject the filth and poison in this man. The potion is of Ibleesi origin and it is laced with poisons and horrific filth. There are many natural remedies to treat this sick man. The Wild Donkeys and baboons of the cartel of UK molvis concede that Allah Ta’ala has created a cure for every disease. The worst kind of disease can be treated with natural, pure home remedies if Allah Ta’ala has decreed *shifa’* for the sick man. He does not have to become a devil and a kaafir for the sake of medicine and cure.

A non-Muslim expert in the devil’s vaccine science, offering the Wild Donkeys some *naseehat* on the principle of the “lesser evils”, says:

“The company cheered in mainstream headlines, MODERNA, that’s claiming to be developing a Covid-19 vaccine, is using human abortion cells to do it. It’s just plain witchcraft, and the benefits (if any at all anymore) do NOT outweigh the risk. Doctors, nurses and pharmacists do not understand this.....” (The full article appears further on)

The talk of ‘striking the right balance’ is pure copro-rubbish. Thousands of atheist experts and scientists dismiss this satanic twaddle and have elaborately expounded the satanism underlying the concepts and plots of the Pharma Terrorists. What is their basis for their Pharma fed averment that the conspiracy facts (not theories) and information are baseless? The innumerable articles and books published by experts in the field thoroughly debunk the effluvium of falsehood excreted by the Wild Donkeys. If these satanic Donkeys consider

themselves to be experts in the field, they should scientifically, logically and academically examine and refute the convincing narratives of the experts who provide the facts regarding the plots and conspiracies of the Pharma Satanists.

Since the minab UK Wild Donkeys are peddling an agenda provided by the plotters whose conspiracies “move mountains”, nothing better than bootlicking can be expected from these vile molvis who have the hearts of wolves. An arbitrary dismissal of the information pertaining to the Pharma conspiracies is devoid of substance. The Qur’an says: ‘O Believers, if there comes to you a disobedient one with information, investigate, lest you harm a people out of ignorance and become, over what you have done, regretful.’ (Qur’an 49:6)

Confusion and deception are being perpetrated by the UK Wild Donkeys. They are the satanic culprits to whom applies the aforementioned Aayat which they have cited. They who lap up whatever the atheists din into their ears come fully within the purview of this Qur’aanic Aayat. The sinister objective of their pursuit constrains them to intransigently refute the vast armoury of facts and information which the anti-Pharma experts have presented to substantiate their conspiracy claims.

Lives at risk?

Another stupid claim devoid of any Shar’i basis stated by the Wild Donkeys is their averment:

“We are potentially putting the lives of others at risk, in particular those who are at greater risk of catching covid. We all have a responsibility to take care of one another, which is something our religion, Islam, places an enormous emphasis on. The famous prophetic tradition

*states: “There is no causing harm or reciprocating harm”
(Ibn Majah).”*

On the contrary it is Waajib to inform people, especially the sick, to abstain from the potion of Shaitaan. Deceiving people and tricking them into vaccination is a capital crime. In their support for the Pharma vaccine gang, the U.K. Wild Donkeys are on the precipice of kufr or perhaps they have already ventured into the domain of kufr with their vaccine advocacy. The harms and dangers of the vaccines have been convincingly proven by experts in the field. But, these miserable Wild Donkeys are mismanipulating the Qur’aan Majeed for a despicable objective, for appeasing the government – *hub-e-jaah and hub-e-maal*. When this is the case despite the permissibility of resorting to lawful medicine, what conclusion is to be drawn from the moronic advice and insistence to use haraam, harmful potions –

concoctions of Iblees – for sickness, and even for inducing sickness in healthy persons?

Rasulullah (Sallallahu alayhi wasallam) and the Sahaabah did not place people at risk of becoming infected with the disease or at the risk of death when during epidemics they huddled together in the Musaajid supplicating to Allah Ta’ala. Not a single attempt was made to adopt any measure in an effort to stem the tide of the epidemic. The epidemic runs its divinely decreed course against which no physical means were adopted. The only reaction was Sabr and Dua. The only reaction was Sabr and Dua. The nifaaq of these Wild Donkeys is quite apparent from their accordance of a Qur’aanic pedestal for the haraam, satanism of the atheists.

Islamophobia?

The Wild Donkeys of minab arrogantly flaunting their *jahaalat* say:

“We are potentially bringing disrepute to Islam. We do not want to fan the flames of Islamophobia and give rise to scapegoating communities as we continuously saw during last year.”

You morons are bringing disrepute to Islam with your *fisq* and *kufr*. Misdeeds of Muslims have fanned and

are fanning the flames of Islamophobia. Bootlicking and hind licking are not the answers for Islamophobia.

‘Islamophobia’ is in fact an *Athaab* from Allah Ta’ala. This punishment cannot be averted by bootlicking, deceit and selling Imaan and the Shariah to appease the kuffaar. The Musaqjid will be beautiful ornate structures, but devoid of Huda (Islamic Guidance). The Ulama will be the most evil of the people under the canopy of the sky. From them will emerge fitnah, and the fitnah will rebound on them.”

The most disreputable members of this Ummah today are the ulama-e-soo’ who excel in bootlicking and hindlicking of the kuffaar. These Wild Donkeys fleeing from the Shariah have ruined the Ummah. They excel in the satanic art of undermining the Deen. Shaitaan has recruited the Wild Donkeys to execute his pernicious scheme to ruin this Ummah and to destroy its Deen.

(Al-Munaafiqoon, Aayat 8)*

Izzat is in strict adherence to the Sunnah. Allah Ta’ala bestows dignity, honour and awe to the Mu’mineen, and they are only those who follow the Sunnah. Bootlickers such as these Wild Donkeys are disgraceful vermin and spineless epistasis. About these hindlickers, Rasulullah (Sallallahu alayhi wasallam) said that they will emulate and follow the Yahood and Nasaara right into the “*lizard’s hole*”. Everything disgraceful and harmful of the Yahood and Nasaara will be adopted by the Wild Donkeys and considered to be honourable.

They should hang their heads in shame or get rid of themselves to purify the Ummah rotting with the cancerous gangrene of their fisq, fujoor, bid’ah and kufr. Is it the obligation or the function of Ulama to become advertisers and promoters of the satanic vaccine on behalf of Bill Gates and the Pharma Satanists? The smattering of their scrap knowledge about vaccines is an augmentation of their own *jahaalat* by the misinformation fed to them by the Pharma Satanists whom they worship and bootlick in pursuance of their despicable worldly and nafsani goals.

The charge that Muslims “*don’t believe in a treatment*”, is a satanic canard. What is the basis for this blatant falsehood? Yes, Muslims do not believe in satanism. Vaccines are part of shaitaniyat. Rejection of satanism is not synonymous with rejection of treatment. Muslims are saying that it is incumbent to abstain from filth and haraam. Rasulullah (Sallallahu alayhi wasallam) said: “*Allah did not create the cure of my Ummah in things made haraam from them.*” Innumerable experts have highlighted the satanism of vaccines with irrefutable evidence – evidence which the vaccine cartel has failed to neutralize. The only reaction of the Satanists is a summary, stupid dismissal of the claims of the anti-vaccine scientists and experts. While the latter present facts, figures, medical and scientific evidence to debunk the falsehood of the vaccine Satanists, these inhuman creatures have failed to vindicate their position rationally and scientifically.

In support of the Pharma Satanists, the minab Wild Donkeys proffer the Qur’aanic Aayat: “*Ask the people of knowledge if you do not know.*” To understand the filth and poison of vaccines, it is ludicrous to turn to the *juhhaal* bootlickers of minab. They are conspicuous serfs of the Pharma Cartel. Added to their ignorance is their blatantly worldly agenda which constrains them to manipulate the Qur’aan and Hadith – the Deen – for the attainment of their despicable objectives. They are adequately depicted in the Hadith which mentions that among the signs of Qiyaamah will be molvis, sheikhs and imams who will “*search for the dunya with the acts of the Deen.*” Thus, it is observed that these moron scholars for dollars using the Qur’aan and Hadith to ply their despicable trade, perfidiously selling the Deen to promote the Devil’s Potions on behalf of their Pharma Satanist bosses and the government for the contemptible gains of the dunya.

Whose medical opinion?

Another stupid red herring let loose by the Wild Donkeys is their averment:

“Additionally, there is a stark warning for someone who provides a medical opinion, when he/she is not qualified to do so and brings about harm to others.”

This is their self-indictment. It is fully applicable to these Wild Donkeys who have set themselves up as experts to ‘prove the goodness’ of Shaitaan’s Potion. They are the juhhaal who are ‘providing medical opinion’ based on their ignorance. What are their qualifications in medicine to entitle them to proffer medical opinion on the hallucinatory ‘goodness’ of vaccines? On the other hand, those who condemn the Devil’s Potion do not offer ‘medical opinion’. They simply narrate what the genuine experts say. They narrate the opinion of the experts, not their own opinion. The moron Wild Donkeys are causing proven harm to countless ignorant Muslims with their

insistence on the benefit of vaccines which they satanically pass off under Islamic guise.

Then the morons cite the following Hadith in favour of the Pharma Shayaateen: *“Whoever practices medicine without having studied it shall be responsible (for any harm he causes).”*

Those Ulama who condemn vaccines, do not “practice medicine”. Their condemnation of the Devil’s Potion is mere narration of opinions from the experts. The Wild Donkeys in pursuance of their despicable worldly objects believe that they have the right to disseminate the opinions of the Pharma Cartel. On what basis do they seek to deny the Ulama the right to warn the Ummah of the danger and harms of Shaitaan’s Potion? The warning of the Ulama is based on the evidence provided by the experts. In so doing, the Ulama are not practicing medicine as the morons are implying.

Muslims should not allow themselves to be deceived by the Pharma propaganda peddled by the Wild Donkeys of minab. Their claims are blatant lies. In the drivel they have written it is mentioned:

“Islamic scholars have allowed taking the vaccine either on the grounds of or on the basis of necessity or

istihala (change in the nature of the impermissible substance).”

Who are these moron scholars? They can be only fools and quacks of the likes of the Wild Donkeys.

Although the Wild Donkeys have laboriously, but abortively, struggled to convey the fallacious idea of the ingredients of vaccines being halaal, they nevertheless, speak of ‘*istihaalah*’. If they are convinced that the ingredients are halaal as they have maintained, then what is the purpose of introducing the *istihaalah* factor? This shows that the truth of the filth and haraam ingredients cannot be unequivocally denied.

Apart from the issues of haraam ingredients and the process of *Istihaalah*, the fact is that Islam does not permit the introduction of a disease into the body. Introduction of disease whether in healthy or sick persons is haraam. It is by satanic inspiration that human beings are perpetrating the grotesquely evil of injecting disease into people by means of vaccination.

Looking at haraam for the acquisition of benefit is total lack of Tawakkul on Allah Ta’ala. While Tawakkul is not nugatory of halaal medicine, it strictly proscribes rijs and haraam. The minimum degree of Tawakkul

One in Every 16 Irish Boys has Autism: Crisis Worse than COVID-19 and Nobody Cares

According to National Health data released last week, autism incidence among Irish children is now at 4.3%, an 82% rise in five years. One in 16 boys is affected. US rates trail Ireland's slightly only because CDC lies to minimize the crisis.

Baby foreskin being used to make vaccines

Every year, some infants are circumcised. During this surgical procedure, part of the child's protective penile tissue is removed. Certain microorganisms used by vaccine companies need living human cells to replicate. The cells within foreskin are being used for this purpose. Foreskin cells can be used to turn a wild-type microorganism found in nature into a genetically modified microorganism for use in vaccines.

Baby foreskins are used to research rubella, varicella and human papillomavirus (HPV) vaccines. They are used to make cytomegalovirus vaccines, which is something pharmaceutical companies have been working on the last few decades. This vaccine is being created using foreskin cells and clinical trials have already begun. The child's DNA whose foreskin was used to make the vaccine cannot be fully removed from the vaccines prior to administration. Researchers are also using foreskin to create a human telomerase reverse transcriptase (hTERT) immortalized cell line for use in vaccines.

Cells isolated from infant foreskin are preferred because the infant cells have a longer lifespan than those isolated from adult foreskin. The ongoing issue with companies using infant

foreskin to develop vaccines and other products is vast; only a small fraction can be discussed here. It is important to research how vaccines are made prior to receiving them, if you want to avoid unwanted contaminants in your body.

Hospitals and Clinics Can Sell Foreskin Removed from Newborns

What we call foreskin is actually part of a whole skin system in both males and females. During the male circumcision procedure, twenty to fifty percent of the skin that protects the baby's penis is surgically removed, with or without pain medicine. There are occasions where surgical accidents happen and more is removed.

If a hospital or clinic obtained consent to use the foreskin for purposes they felt were desired, the removed foreskin may then be sold at that point, even if the baby didn't survive.

DOCTORS CANT FIND CAUSE FOR MANY DISEASES?
